Rector Robert A. Shared Governance Discussion

- Shared governance involves identifying, developing and supporting common goals;
- Shared governance involves shared understanding of stakeholders' roles and their accompanying responsibilities;
- Shared governance requires commitment to its guiding principles and process;
- Shared governance feeds timely, well-informed decision-making and improves morale;

- Shared governance results in shared, connected, empathetic understanding among diverse stakeholders via on-going, transparent communication.

Members discussed potential next steps, which included live-streaming of Board of Visitors meetings, orientation practices and participation in meetings. Mental health issues among students and enrollment and retention were identified as potential topics for discussion at future meetings.
